#### **CONFIDENTIALITY POLICY**

It is the policy of Loaves & Fishes Food Pantry, Inc.(L&F) that its Board of Directors members, volunteers, and employees will not disclose confidential information belonging to, or obtained through their affiliation with L&F to any person, including their relatives, friends, and business and professional associates, unless L&F has authorized such disclosure. This policy is not intended to prevent disclosure where disclosure is required by law.

Confidential information is defined as any aspect of interaction with clients of L&F, donor information, and any financial or proprietary information. Keeping the identity of our clients confidential is particularly critical. Unless acknowledged by a client first, employees and volunteers are not to approach a client in public.

Board members, volunteers and employees are cautioned to demonstrate professionalism, good judgment, and care to avoid unauthorized or inadvertent disclosures of confidential information and should, for example, refrain from leaving confidential information contained in documents or on computer screens in plain view.
